(The wife and daughter of Gabriel Gardner, owner of former Mitchellville land. His father, March Gardner, bought the land, but when Gabriel went to get the deed, he put it in his own name.) A large parcel of land, they rented it out to others to farm, and later, the descendants of March and Gabriel fought each other in court over rights to the property. These court cases dragged on for approx. 10 years, between 1911-1920)

The Gardners of post Civil War Hilton Head Island

The family of March Gardner most probably took its surname from Benjamin Gardner, owner of the Gardner Plantation, lot number 11 of Bayley's Barony, the nucleous of present day Honey Horn property. Lot 11 was comprised of 270 acres on the south shore of "Crooked Creek", as of 1783.

"Gardner's' grew to be a large plantation of 1424 acres on the north side of Broad Creek, bounded on the east by Marshlands and Sand Hill, on the west by Otter Hole (Otterburn) and on the north by Pineland Tract and Hanahan's (Honey Horn). It was also probably the home of Charles Davant, murdrered at Two Oaks during the Revolutionary War, but is referred to in part as belonging to Col. "Garden" in a boundary listing dated 1795.

In an article of "The New South" newspaper dated November 7, 1863, mid War, posting LAND FOR SALE, included: "... Gardner - Said to be, or to have been owned by Stoney. One thousand acres."

According to Virginia C. Holmgren in <u>Hilton Head</u>, <u>A Sea Island Chronicle</u>, in her chapter entitled "The Dark Years of War", Gardner's was included in plantations that fell to the auction block. A group of investors called "The Sea Island Company" purchased Gardner's in addition to Otter Hole and Leamington. An old record book was found at Otter Hole listing an inventory from 1866:

Gardner's

550 acres arable land (cotton)...\$100 per acre

874 acres timber land.....\$55 per acre

1 mansion.....\$4,000

25 freedman's houses......\$7,500

1 cotton drying arbor.....\$500

1 horse barn, very large.....\$3,000

It also lists other items such as a blacksmith shop, carpenter shop*, plows, brooms, tobacco, seed... a total of 300 items. The Gardner mansion was appraised at merely one fourth its former value. Land value dropped, cotton prices dropped.. *(March Gardner was a carpenter)

This change was due partly to a special field order issued by Gen. Wm. Tecumseh Sherman., Order #15 on January 16, 1865. (Apparently, clever March Gardner jumped right in, purchasing his land from young Mr. Drayton, Willie Drayton, in about 1865, according to the resulting court case) This order limited the sale of all sea island land to Negroes only. It also set aside a strip 30 miles in width along the coast from Charleston to the St. Johns River in Jacksonville Fl., the best rice growing lands, for Negro purchasers only. New land purchases made by Negroes came under the auspices of the newly formed "Freedman's Bureau", headed by Gen. O. O. Howard. Howards agent on Hilton Head was one Gen. Rufus Saxton who was appointed by the Army to handle Negro affairs. He reported on a huge territory (SC, Georgia and Florida) and ultimately 485,000 acres of land was sold to 40,000 Negroes. A group of 3 Tax commissioners indicated which land was sold, and

government surveyors marked out the boundaries. It was done hurriedly and haphazardly and the diagram of land sales on Hilton Head island looked like a crazy patchwork quilt!

As we know, large land owners had a hard time returning to find their mansions burned down, farmland destroyed, and Negroes or Northerners living on the property. Many just left, and were taken in by relatives elsewhere. Here's how a little of it looked for some of the Hilton Head families that we have known and followed:

The Elliotts, Lawtons and Mathews were able to regain most of their former holdings. The Draytons, Popes and Baynards obtained only part, and the GARDNERS got none of their plantation back, but did manage to buy land nearby. No other families are listed in the files of the Redemption Certificates of the 1870's. March's future land, Mitchelville, was formerly the Drayton Plantation. March was buying up Mitchelville land in the last twenty five years of the nineteenth century, 1875 through 1900. It is implied, in the logs of the court case, that he began in 1865. How could this be if records show that the Drayton Plantation was returned to the heirs of its pre- war owners in April, 1875? The heirs were'nt interested in planting there and began selling it to freedmen like March Gardner. He was illiterate and trusted his son, Gabriel, to have a proper deed made up. This was a poor decision. Gabriel had the land deeded to himself, and later transferred it to his wife and daughter.

Statements from the Court Case, July 11, 1911

The actual case was called Clara Wigfall and others, Plaintiffs Against James Heyward and others, Defendants. March's child(ren) suing Gabriel's child, husband, and children in the Beaufort Court of Common Peas. It was Clara Wigfall, Emmeline Washington, Linda Perry, Gabriel Boston and Celia Boston (heirs of March) Vs. James Heyward, Lillian G. Pearson, Lavinia Howard, Henry Howard, Clifford Heyward (heirs of Gabriel's wife) for 154 ¼ acres of land encompassing most of Mitchelville (Beaufort County RMC, Judgement Roll 2795).

Clara Wigfall, daughter of March Gardner testifies in court papers dated 1911 that her father bought land "from Willie Drayton". "When my father bought the land, Gabriel was in Charleston. They say he sold whiskey to the soldiers and his time was not up. He was in jail.."

Sixty two year old Stephen Singleton testified that he knew March Gardner, and that he lived in Mitchelville. "He was a carpenter and worked for Mr. Lindsey." (July 11, 1911) He also recalled that after Gabriel died, Thomas Wigfall (March's son-in-law) had charge of the land. Everyone involved seems to agree that Gabriel never acted as though he owned the land when March was alive. Thomas Wigfall, March's daughter Clara's husband, testified that Gabriel lived about 4 or 5 years longer than his father. He implies that July Heyward, Sarah's husband and Gabriel's son-in-law wanted him to collect rent from the tenants of the land and give it to him. He refused. July was telling the tenants that the Probate Judge told him to collect the rent. He also mentions the Fish Haul land, it being separate from Mitchelville (as noted in the Holmgrem book, see below) He states that Gabriel's wife Susan died last October one year, October of 1910. They both lived on the Mitchelville land right up until their deaths.

Gabriel P. Gardner is listed among Hilton Head postmasters. After the War, the name Hilton Head once again became the correct postal term, not the wartime "Port Royal", or Mitchellville. Gardner was postmaster from 1882 (appointed June 29) to 1886. (Holmgren's Hilton Head, A Sea Chronicle, and Appointments of U.S. Postmasters, 1832-1971)

A Dr. F. E. Wilcher's sworn statement tells of March Gardner being a successful businessman. "He had quite a store, built a mill, cotton house and grist mill and put up two large buildings. Gabriel Gardner was not successful. He was in debt when he died...Gabriel was a preacher.." (December 18, 1911 testimony)

After having been sold to the Sea Island Co. by the Federal Government; The"U.S. Cotton Co." then bought it and sold it to J. L. Dimmock, who sold some of it to Negroes and most of it to W. L. Hurley of New Jersey. March Gardner did make some claims for land, and his son Gabriel P. Gardner, bought part of **Fish Haul**. Gabriel's wife Susan and daughter Sarah kept the land (35 acres) but granddaughter Eugenia Gardner Heyward let it be sold for delinquent taxes. Roy Rainey picked it up and later (only 10 months later!) sold to Thorne and Loomis in 1931.*

As for the Mitchelville land, the heirs of March Gardner took the heirs of Gabriel Gardner to court. One of these heirs was Emmeline Washington, daughter of March Gardner (and sister of Gabriel).

The court decided that a survey be taken and the Mitchelville property be divided evenly among the heirs of both families. Eugenia Hayward (on the Gabriel side) received 35 acres on June 7, 1923. Celia and Gabriel Boston obtain an adjacent tract on September 2, 1921. Linda Perry, Emmeline Washington (on the March side), and Clara Wigfall also claimed their parcels of land in 1921.

By 1930, the Eugenia Heyward's 35 acres were sold for \$31.00 to pay a defaulted tax bill of \$15.00 by the Sheriff's Dept. to Roy Rainey of New York, who was purchase huge portions of the island for exclusive hunting parties.

Celia and Gabriel Boston's 28 acre tract was sold to a Johnnie White on March 15, 1943 for \$20.00 by the Sheriff to settle delinquent taxes (Beaufort Co. RMC, DB 88, p. 58)

An interesting bit of info.. March Gardner's store, opened in the early 1860's was still being run by Susan B. Gardner(his daughter-in-law)into the 1890's. An anonymous source reported that it was one of six general stores on the island in 1892.

As more and more of the island property changed hands, the black population was reduced, and by 1936 there were only 300 Negroes on the Island, compared to the 3,000 forty years before.

Gabriel P. Gardner

According to 1880 Census data, Gabriel was born c. 1840 in SC. In the year 1880, he is head of household at age 40 with wife Susan, 38, and daughter Sarah, 19. He lists his occupation as 'retail

grocer', and Sarah as 'clerk in store'. Next door neighbor Eugenia Washington, age 38, farm laborer, is listed with her children Susan, Thomas, Joseph, Jonas, and Julia; and an 80 year old Susan Gardner.

Here are some of the tenants of the Gardner/ former Mitchelville land: John Nesbit, Bob Washington, Caesar White, Charles Robins, Charles Perry, Robert Wiley, Scapio Drayton, Jack Screven, Charles Pinckney, Billy Reed, Peter Flowers, and Joe Williams, Hannah Williams...

*Landon Thorne and Alfred Loomis sold their property, which included the former Mitchelville, to "The Hilton Head Company" on March 22, 1950, which became "Hilton Head Co., Inc." when it merged with Port Royal Plantation and Island Development Corporation.
