My dear Mrs. Murphy,

Mrs. Annie E. Miller has sent me your letter of the 16th addressed to me but sent to her. I have read it with a great deal of interest, and it gives me a great deal of information about the Lawton and Robert families that I did not know. For example, the year of the birth in Wales of the first Joseph Lawton, the date of his emigration and the date of his death. As you have evidently taken a great deal of pains to get facts, I take it for granted that you have verified this and they interest me a great deal. I shall transfer this information to such a record as I have, which I am sorry to say is not complete.

I am not much of a research man and, while I naturally am much interested in the genealogy of the family, I do not seem to be enough of an enthusiast to devote much time to it in connection with the other things which I have to do, whether I care to do them or not. I have quite a number of letters and memoranda that have not been properly transcribed, including some to which I attach very little importance, because they evidently record only impressions and rank hearsay, instead of ascertained facts.

Going carefully over your letter, I take pleasure in answering your questions as far as I can, and giving you such memoranda as seem to be material.

Corinne Lawton Mackall's husband is not Carl Melchers, but Gari Melchers. He is one of the most distinguished of our American painters, having, with Sargent and Whistler, taken in Europe all of the honors to which an American artist is eligible. His name was originally Julius Garibaldi Melchers, and he had the good sense to contract it to Gari Melchers. He is still alive, active in his profession and receiving many honors. They have no children.

My youngest Grandson is not "Spender Lawton", but Spencer Lawton.

I regret to say that I know nothing of the name Bettison. I am hearing it in your letter for the first time.

I have never heard of any one named Rennock or Romeock.

All your information about my immediate branch of the Lawton family is correct, except insofar as I have indicated changes. I wish I had some further information I could give you. I presume (by Dr Hirsch, I think) you have the recently published book on the Huguenots of South Carolina, which shows a great deal of research and gives a great deal of information; among other things, that Pierre Robert was the first Huguenot Minister to preach in South Carolina.

You refer to his will. His will, and I think also the will of his son, Pierre, 2nd., were printed in the transactions of the Huguenot Society of South Carolina several years ago. I should guess it was approximately ten years ago. My recollection is that the print shows the original French and an English translation.

I think this is all the information I can give you, and I much regret that it is not more.
