\*\*\*\*\*



Rita's husband Hugh descended from RAWLINS who went from England to the Caribbean islands, particularly St. Kits- She notes that sometimes we don't research enough and told of discovering that members of Hugh's family in the 1600's on "commuted" back and forth from the islands, Canada and the United States. One ancestor whose parents and grand-parents went to St. Kits from England...returned to England, married a girl in Ireland and the couple had one child, and then went to Canada where they had several more children, and then travelled on to Norfolk, Virginia. Descendants of that line now live in Pittsburgh, PA. Almost unbelievable!

DEED - Nov. 2, 1686 - Miles Gibson, for 9,000 pounds of tobacco, conveying to JOHN RAWLINGS, planter, 150 acres, being half of tract "Collets Neglect" at Elk Neck Creek in Gunpowder River, said tract formerly granted to George Holland, and later being the dwelling plantation of Michael Judd. Witnesses: Mark Richardson and Miles Gibson. John Hall, sub-sheriff, received 6 shillings from RAWLINGS for alienation. (?)

From a query found in the Genealogical Helper, September 1962:

According to Robert Barnes in his "Notes on the RAWLINGS FAMILY of Baltimore and Anne Arundel Counties, Maryland"- October 1981, this query refers to a MICHAEL RAWLINGS listed in the 1750 Debt Book of Baltimore County, Maryland, and owning 50 acres of CHATTOM. This guery stated that this MICHAEL RAWLINGS died ca 1774-1776 in Washington Co., PA, and that he had one child JOSHUA, b. ca 1766 who died 1801 in Bourbon Co., Kentucky., and who had married Verlinda Darnall ca 1789. (Mr. Barnes had been doing some research for a Dr. Martin.) Those members of R/RFHA who have been researching the family which includes NATHAN, ASAHEL, MICHAEL, MOSES et al (RAWLINGS) in an attempt to solve the various mysteries of this family might be surprised to note this particular information since the Washington Co., PA MICHAEL RAWLINGS in whom they are interested is usually considered as dying 1780/81, leaving his widow Mary and children young enough to require a tutor since she appears before the Orphan Court asking for sums for that purpose. Perhaps those interested should locate this particular issue of the THE PROPERTY OF THE PARTY OF TH GENEALOGICAL HELPER.

Further to the Maryland RAWLINGS; there are various mysteries concerning similarities in names. For example, DANIEL. There is the line that seems in some way to be connected with the NATHAN-MCSES-ASAHEL-MICHAEL etc. family ca 1720-1800 in Maryland, Virginia & Kentucky, who some say were Quakers although they fought in the Revolutionary War. And there is the true Quaker DANIEL RAWLINGS of Calvert County, MD, mentioned prominently in Quaker histories and records. Here is what Bev Allan has discovered about his line for two generations:

## Randolph Co., North Carolina, Court of Pleas and Quarter Sessions, November Term, 1843, to the County Court of Randolph.

The petition of AGNES ROLLINS represents to Your Worship that her late husband, JOHN ROLLINS, departed this life in the month of September last, Intestate, being seized and possessed of a tract of land in said county on the waters of Craway adjoining the lands of Solomon Briles, Azel Rush and others, containing 166 acres. Your Petitioner further represents that the said ROLLINS left the following children of full age surviving, to wit: CATHARINE, wife of Jacob Briles...ALLEN ROLLINS...CYNTHIA, wife of Frederick Briles...SALLY ROLLINS...ALEXANDER ROLLINS...PATSY, wife of James Jerrill...WILLIAM ROLLINS...ULISANT ROLLINS...LINNY ROLLINS...and GENERAL HARRISON ROLLINS, all of Randolph County. The four last mentioned being minors under the age of 21 years, and without guardianship, plus POLLY, wife of Kiana Collier...ELIAS ROLLINS, ANNA, wife of Thomas Gee...JOHN ROLLINS.. BETSY, wife of JCHN NICHOLAS...and DANIEL ROLLINS who live beyond the limits of this state.

Your Petitioner prays that Your Worship will appoint some suitable person Guardian of said minors, and that you will cause dower to be assigned to

her according to law, and that she is in duty bound will every prayse (sp).

Note: POLLY, ELIAS, JOHN, ANNA and DANIEL lived in Martin and Green Counties, Indiana.

Also it seems that, according to family group sheets, JOHN RCLLINS was married twice; the first marriage being to Nancy Cunningham, and the second to the petitioner Agnes (Dockery) RCLLINS. It is possible that the children who left to live in Indiana may have been from the first marriage.

'Mearly every town has at some time in its history had one or more odd characters as residents. We have had several such people in Piqua, Chio, among the earlier of them being 'Uncle JCEN RAWLINGS', a very eccentric individual, who was off on the subject of money. He was a tall, slim man, always in a hurry, and invariably carried a cane. He was called 'Covernor RAWLINGS' as he claimed to be governor of the world. He always walked fast on the inside of the side-walk and would cross the street if crowded to the outside.

He lived on the north side of Ash Street between Wayne and Downing, and was always clean and neatly dressed. He would often whirl around a tree or lamp-post several times, then cross the street diagnonally and resume his walk.

He walked many miles each day, molested no one, and attended strictly to his own business. When he wanted money he would go to the old picua Bank and call upon the President, William Scott, or the cashier, Joseph G. Young, and tell them what he wanted. The Cashier would pretend to write him a check and he would go away perfectly satisfied. He claimed to own the bank, and would call for money when he thought he needed it. Uncle JCHN died many years ago, but the memory of his eccentricities remain fresh in the minds of the older citizens of Pigua."

Submitted by Elsie Dokes, a charter member of R/RFHA now deceased, along with much other research she conducted on the family of MCSES RAWLINGS who was killed by indians in 1787 in Kentucky. Her niece Shirley Draheim, also a member, has carried on Elsie's research. "From Mrs. Lathrop in 1955, a descendant of NATHAN RAWLINGS, MCSES' brother it is believed, and NATHAN's wife Mary (Rankin)'

From Deed Book #1, P.612 - March 6, 1801.

NATHAN RAWLINGS and his wife Mary bought of James Blackburn 110 acres in Harrison Co., Kentucky; price 250 pounds. Land was lying on the South fork of the Licking River.

From Mrs. Lathrop's research she had determined that NATHAN and Mary (dtr. of David Rankin and Hannah Grovence) had 7 children: NATHAN Jr., JAMES, BENJAMIN SCOTT, PROVENCE, SARA, JANE and POLLY. Several county histories in Illinois name another son, MICHAEL. This MICHAEL was married in Lawrence Co., Ill. to Jennie Johnson/johnston in 1824 NATHAN's brother MCSES' sons were EZEKIEL, MCSES Jr., NATHAN, DAVID, SAMUEL, ASAHEL and maybe another MICHAEL. EZEKIEL and ASAHEL remained in Kentucky while his other sons travelled to Ohio and elsewhere. We have several descendants of both NATHAN and MOSES as members.

### Some Ohio Records

MOSES RAWLINS came from Maryland as early as 1808 and took a fifteen year lease on a part of Edward Williams' place, opposite the farm now owned by PhilomeneGray. There he raised twelve children, five of whom are still living. A son EZEKIEL married twice. He settled in Scioto County and had twenty-six children, seven by his first wife and nineteen by his second, who survives him. (some say his first wife bore him 9 children and his 2nd only 17. Who's counting?)
Moses was born in Maryland but he came to Ohio via Kentucky. This MOSES was the son of MOSES (1720-1787)

Only one child is noted from the marriage of EZEKIEL RAWLINGS and Elmira (sp) McDonald. This was DANIEL, b. 1842; died Feb. 14, 1863, as a combatant in the War Between the States, at St. Louis, Missouri.

Here is the will of a GEORGE RAWLING of Prince Georges Co., Maryland. To which Maryland family does he belong?

In the name of God, amen, I GEORGE FAWLING Sr. of Prince Ceorges Co.in the state of Maryland, being of sound and disposing mind and memory, but considering the uncertain time of this transitory life, do make and ordain this, my last will and testament, in manner following, after first commending my soul into the merciful hands of Almighty God. I give and dispose of my worldly estate in the following manner, VIZ

I give and bequeath to my daughter ANN RAWLING one bed and furniture the best I have excepting one:

I give and bequeath to my dearly beloved wife REBECCAH RAWLING the remaining part of my estate during her widowhood. And after, it is my will that the remaining part of my estate except what is willed to my daughter ANN above be equally divided between my nine children - THOMAS, MARY, ANN , GORDEN, GEORGE, JOHN, SARAH, PRISCILLA and WILLIAM RAWLING.

Lastly I do hereby nominate, ordain, constitute and appoint my dearly beloved wife REBECCAH whole and sole Fxecutrix of this my last will and testament, revoking and making void all other will or wills by me heretofore made. In witness whereof I have hereunto set my hand and affixed my seal this Eighth Day of March one thousand seven hundred and eighty-two.

Signed, sealed, published, declared by the aforesaid GEORGE RAWLIN as and for his last will and testament in the presence of us who subscribe the same as evidence in his presence, at his request, and in the presence of eath other.

This concerns the family of JOHN HOLLADAY\*RAWLING of Spotsylvania Co., Virginia, Clark County, Kentucky and Howard County, Missouri Territory. (see end of article for reason for asterisk - Ed. note)

The patriarch of the RAWLINGS family of Howard County, Missouri, was JOHN HOLLADAY RAWLINS, son of JAMES RAWLINS and Sara Elizabeth (Holladay) RAWLINS. He was born April 8, 1747 in Spotsylvania Co., Virginia. and died in 1820 in Howard Co., Missouri. JOHN's father was one of six children of JAMES RAWLINS Senior, wife's name unknown. The elder JAMES was born ca 1680 in England and died April 9, 1757, in Spotsylvania Co. Will Book B, A. 314. This family was primarily Methodist for generations. Sarah Holladay was the daughter of the fabled JOHN HOLLADAY, a captain in the Virginia Rangers (Colonial).

JOHN HOLLADAY RAWLINS father JAMES was born ca 1710/20 and died June 5,1784. In the June 4 issue of the Baltimore Sun's genealogical column there is much detail on this family down thru several generations.

The subject of this research by Neil Smith is JOHN HCLLADAY RAWLINS. His first wife was Nancy Holladay who was the mother of 8 of his children.



They were THOMAS C., MARY, BENJAMIN H., LEVI, JOHN W. (probably Wesley), SUSANNAH (who died at age 4), ROBERT and OWEN. They were probably all For some reason all the children went with JOHN born in Virginia. and Nancy to Kentucky with the exception of LEVI, who remained in Virginia with relatives. Nancy died in January of 1800 in Kentucky. It wasn't long after that JOHN married the widow Jane Embree. maiden was Bush. By Jane he had 6 more children - JAMES DAWSON, WILLIAM, ELVINA, JULIA C., JANE and NANCY. The family left Clark Co., Kentucky 1817/18 and moved to Howard County in the then Missouri Territory. It wasn't long after that JCHN HOLLADAY RAWLINGS died, and then began a series of court actions regarding his will, guardianship of the minor children, and it seems the children of Nancy had problems with JOHN's 2nd wife being made Executrix of the will. Eventually it was all sorted out, but if any of the readers want the details contact Neil. He's done a masterful job of getting the facts straight.

It might be noted that some of the elder children did very well for themselves. THOMAS became an Howard Co. Justice of the Peace. OWEN later became an Howard Co. Judge and a prominent Missouri legislator. JOHN W. later became guardians for the younger children of Jane and JOHN HOLLADAY RAWLINGS. That same JOHN W. married Mildred Embree, and his sister MARY married Jonathan Bush. THOMAS C. also married a Bush, Esther. Nothing much is heard about BENJAMIN, born in 1796 in Virginia, or of ROBERT born in 1794.

Of the children of JOHN HOLLADAY RAWLINS and Jane, JAMES DAWSON RAWLINS had an itchy food which took him up into the northern part of Illinois where he hunted and guided and tracked, returning to marry Lovisa Collier in Howard Co. in 1828. JAMES was born Feb. 28, 1802 in Kentucky, and died in 1083 in Illinois. He had 9 children, among whom was JOHN AARON RAWLINS, aide to Gen. U.S. Grant (Chief of Staff) and later named Secretary of War in Grant's cabinet when he became President.

By 1830 in Howard County, Missouri, according to the Federal Census, J.W...OWEN...and THOMAS were the only RAVLINS listed. In 1840 there was only JOHN W., OWEN, THOMAS and Milly, widow of JOHN W. PAWLINS.

It must be noted that this family, as others of this surname, found their names spelled RAWLINGS, RAWLINS, ROLLINGS and ROLLINS, although the original immigrant was JAMES RAWLINS

\*Now the asterisk. Around the same time and the same general area which included southern Pennsylvania, the Maryland neck, and Virginia...there were two families; one HOLLIDAY, premarily in Pennsylvania...and the other HOLLADAY found in Virginia. Why the difference in spelling one will never know, only that all the HOLLADAYS who married into the RAWLINS family for at least 3 generations, and maybe more, were spelled with the 'a'.

WILLIAM RAWLINGS Sr. - will dated Feb. 22, 1814. In it the testator names his wife Barbara, sons MRESLEY, THOMAS, AAPON and WILLIAM Jr., and daughter MARY Day. Also grandson SAMUEL Day, and granddaughter BARBAPA, daughter of WILLIAM Jr. The will is located in the Fleming County Circuit Clerk's Office, Fleming County, KY.

William Knight of Urbana, Ohio, wrote in 1941 that WILLIAM PAWLINGS Jr. came to Kentucky from Loudon Co., Va. He learned this from his grandfather JAMES R. RAWLINGS who was the son of WILLIAM Jr.

History of Hamilton Co., Indiana by John F. Haines, 1915

William Neal and HANNAH ROLLINGS were united in marriage at her home west of Cicero, in 1840. She was born in Coshocton Co., Ohio, Feb.14, 1822, the daughter of WILLIAM K. and Susan (Hershman) ROLLINGS. Her father was born at Harper's Ferry, Maryland. The family came from their Ohio home as pioneers to Hamilton County about 1837, travelling by wagon along a "blazed trail". The mother succumbed to the harshness of pioneer life not many years after settling in Jackson Township. WILLIAM K. RCLLINCS remarried and reared another family. We note that two half-brothers of HANNAH gave their lives as soldiers to the Union cause during the War Between the States. CHARLES died in a hospital at Camp Chase, Ohio, April 1, 1864, and ROBERT EDWARD was killed at the Battle of Kennesaw Mountain June 18 the year. William and HANNAH Neal were the parents of a large family. Of their children, JAMES S., MARY A., LUCULLUS G., CHARLES M. and MOSES died very young. Those who grew up were SARAH C. married to Dr. A.B. WILLIAM WORTH who died in an accident at age 20; THOMAS D. Mendenhall; married Frances Martin; MARTHA H. was the wife of James M. Little; FRANCES A. died at age 15; RICHARD P. married Dovey J. Parent; JOHN F.; SUSAN L.; and EDWARD E. married Mabel Beall. All the married children reared families. RICHARD died at his home in Cicero September 30, 1906 aged 49.
