Richardson, John (1816 - 11 Sept. 1873) Born in Edgefield Dist., S.C.; by 1854 settled in Savannah, Ga., prospering as a commission merchant and cotton factor. In March 1856 he was elected Vestryman of St. John's Episcopal Church; he was President of the Farmers' & Mechanics' Bank for several years and was elected Alderman of Savannah in Oct. 1859. Just before the War he joined Dr. Edmund Howard Martin (1825-1907), son of Edmund Martin (1796-1871) of Woodstock Plantation, St. Peter's Parish, S.C. and his wife, Mary Anna Maner (1806-1847) who had settled in Savannah in 1848, practicing medicine with Dr. H. L. Byrd, and was one of the eight founders of Savannah Medical College in 1852 in the cotton brokerage firm of Richardson & Martin which flourished until dissolved by mutual consent 29 May 1867. He died at his rice plantation on Pawleys Island, Georgetown County, S.C. 11 Sept. 1873. Survived by his wife, Elizabeth Phoebe Stoney (1820-1876) and was buried in All Saints Episcopal Churchyard, Waccamaw. His widow died in Savannah 15 Sept. 1876 and was buried in Laurel Grove Cemetery there.

William Maner and Jane Asenath May) and Catherine Morgandollar; they were Episcopalians, owned 173 slaves in Barnwell Dist., S. C. in 1860, making Mrs. Richardson one of the great planters of South Carolina; her chief seats were Savannah Plantation and Buckfield Plantation. Their two children were:
