The Connecticut Register and Manual lists the Governors of Connecticut in this order, starting in 1639: Haynes, Hopkins, Willys, Welles, Webster, Winthrop Jr., Leete, Treat, Fitz-John Winthrop, Saltonstall, Talcott, Law, Wolcott, Fitch, Pitkin, and Trumbull, whose term lasted until 1784. A large number is listed for the years 1635-1636--Ludlow, Phelps, Pynchon, Smith, Ward, Westwood. They would have chaired the meetings of the General Court in turn, not served as governor as we know the office.

THE ROYAL ANCESTRY OF WINDSOR FOUNDER ROGER LUDLOW

Roger Ludlow, third son, bapt. Dinton 7 March 1590; d. Dublin, Ireland 1666 (this disagrees with some other sources; see article). Balliol College 1610; came to America 1630; Deputy Governor of Mass. 1634, and of Conn.; m. Mary Cogan.

Thomas Ludlow, of Maiden Brailey, Dinton and Baycliffe, co. Wilts., buried at Dinton, 25 Nov. 1607, will pro. June 1608; m. Jane Pyle, dau. of Thomas Pyle.

Edith Windsor, m. George Ludlow, Esq., will pro. 4 Feb. 1580/1, of Hill Deverell, co. Wilts.; Sheriff of Wiltshire, 1567; son of William and Jane (Moore) Ludlow.

Sir Andrews Windsor, d. 1543, first Baron Windsor of Stanwell; m. Elizabeth Blount.

Elizabeth Andrews, living 1485; m. Sir Thomas Windsor, d. 1485, of Stanwell, co. Middlesex.

Elizabeth Stratton, living 1485; m. (1) Sir Thomas Backchurch; m. (2) John Andrews, Esq., of Bayleham, co. Suffolk.

Elizabeth Lutterell, living 1439; m. (2) aft. 1423, John Stratton, Esq., of Lye Hall, Weston, co. Norfolk, living 1439.

Sir High Lutterell, of Dunster, co. Somerset, d. 24 March 1428; Privy Councillor to King Henry V; m. Catherine de Beaumont, d. 28 Aug. 1435, daughter of Sir John Beaumont, Knight.

Elizabeth de Courtenay, d. 7 Aug. 1395; m. 1359, Sir Andrew Lutterell of Chilton, co. Devon.

Margaret de Bohun, d. 1392, granddau. of Edward I, King of England, and Eleanor of Castile; m. 1325, Hugh de Courtenay, d. 1377, Earl of Devon.

Elizabeth Plantagent, b. Aug. 1282; d. 5 May 1316; m. 1302, Humphrey de Bohun VIII, b. 1276; d. 16 March 1331/2, Earl of Hereford and Essex.

Edward I, King of England, 1272-1307; b. Westminster, 17 June 1239; d. near Carlisle, 7 July 1307; crowned 19 Aug. 1274; m. (1) Oct. 1254, Eleanor of Castile, d. 1290; m. (2) 8 Sept. 1299, Margarine of France.

Henry III, King of England, 1216-1272; b. Winchester, 1 Oct. 1207; d. Westminster, 16 Nov. 1272; m. 14 Jan. 1237, Eleanor of Provence, b. 1217, d. Amesbury, 24 Jan. 1291.

John, Lackland, King of England, 1199-1216; b. 24 Dec. 1166; d. 19 Oct. 1216; m. (2) 24 Aug. 1200, Isabella of Angouleme, b. 1188; d. 31 May 1246.

Henry II, King of England, 25 Oct. 1154-1189, called Curt Mantel; b. 5 March 1132/3; d. 6 July 1189; m. 18 May 1153, Eleanor of Aquitaine, b. 1123; d. 3 March 1204. (She had m. (1) Louis VII, King of France.)

Matilda, b. 1104; d. 10 Sept. 1167; m. 3 April 1127, Geoffrey V "Plantagenet," Count of Anjou, Duke of Normandy; b. 24 Aug. 1113; d. 7 Sept. 1151. (She was the widow of Henry V, Emperor of Germany, who d. s.p. 22 May 1125.)

Matilda of Scotland; b. 1079; d. 1 May 1118; m. 11 Nov. 1100, Henry I, Beauclerc, King of England, 1100-1135; b. 1070; d. 1 Dec. 1135.

Margaret (St. Margaret of Scotland); b. 1045; d. 16 Nov. 1093; m. Dunfermline, 1068/9, Malcolm III Canmore, King of Scots, 1058-1093; b. 1031; d. 13 Nov. 1093.

Edward, the Atheling, b. 1016; d. 1057; m. Agatha of Hungary.

Edmund Ironside, King of England, 1016; b. 989; d. 30 Nov. 1016; m. Ealgyth.

Aethelred II, the Redeless, King of England, 979-1016; b. 968; d. 1016; m. (1) 985, Alfflaed, dau. of Thored.

Edgar, the Peaceful, King of England, 959-975; b. 943; d. 975; m. 965, Elfrida or Ealfthryth, b. 945; d. 1000; dau. of Earl Ordgar.

Edmund the Magnificent, King of England, 940-946; b. 920; d. 946; m. St. Alfgifu.

Edward the Elder, King of England, 901-924; b. 875; d. 924; m. (3) 919, Eadgifu, d. 961, dau. of Sigehelm, Earl of Kent.

Alfred the Great, King of England, 871-901, b. Wantage, Berkshire, 849; d. 28 Oct. 901; m. 868, Ealhswith (Alswitha), d. ca. 905, dau. of Earl Aethelred of Mercia and Eadburgh. Alfred was one of the greatest men in history. He was crowned king at Winchester, 871; founded the British Navy, organized the militia, compiled a code of laws, built schools and monasteries, and invited scholars to live at his court. He was a good scholar and translated many books.

Aethelwulf, King of England, 839-858, d. 13 Jan. 858; m. (1) Osburh, dau. of Oslac, the royal cup-bearer.

Egbert, b. 775, d. after 19 Nov. 838, son of Eahlmund, King of Kent. Egbert was King of Wessex, 802-827, and was the first king of all England, 827-836; m. Raedburh. The male line of kings descend from him to Edward the Confessor and the female line to the present time.

Eahlmund, son of Eafa. "A.D. 784. At this time reigned Elmund King in Kent, the father of Egbert; and Egbert was the father of Athulf." (See Weiss for reference.)

Eafa, son of Eoppa, did not rule.

Eoppa, son of Ingild, father of Eafa, did not rule.

Ingild, d. 718, son of Cenred and father of Eoppa, did not rule.

Cenred, son of Ceolwald, and father of King Ina and Ingild, did not rule.

Ceolwald, did not rule. He visited Rome 688. King Cynegils, his brother, was baptized, 635, by Bishop Birinus at Dorchester.

Cutha, or Cuthwulf, son of Cuthwine and father of Ceolwald and the younger Cynegils, did not rule.

Cuthwine, killed in battle 584, son of Ceawlin and father of Cutha or Cuthwulf, did not rule.

Ceawlin, son of Cynric, undertook the government of the West Saxons, 560, and reigned thirty years.

Cynric, son of Cerdic, was King of the West Saxons, 534-560.

Cerdic, King of the West Saxons, 519-534, was a Saxon Earldorman who founded a settlement on the coast of Hampshire, England, in 495, assumed the title of King of the West Saxons in 519, and became the ancestor of the English royal line.
