The Last Will and Testament of John Milam, deceased.

I, John Milam of the of Alabama Madison County being weak in body though sound in mind and memory do make this my last will and Testament in manner and form following that is to wit.

1st I will and bequeath to my wife Polly Milam one bed bedstead and furniture two wheels and traces one Sorel felly saddle and bridle one hundred dollars in cash one large chest one table and two chairs and one choice cow & calf to have in fee simple to dispose of as shee may think proper.

2^d It is my will and desire that my daughter Dickey Cannam shall retain as her part of my estate one negro by the name of Hannah now in her possession.

3th It is my will and desire that my daughter Jane Leck shall retain her proportion of my estate the negro girl Saitley now in her possession.

4th It is my will and desire that my Executors herein after named shall immediately after my death proceed to sell at publick auction given twelve months here sit a my estate both real and personal to get therewith all my goods and chattles of whatsoever nature or kind and the money arising from the sale of said property to be equally divided amongst my heirs after named that is to say my son Bartlet Milam, John Milam, Wiley Milam, my daughter Polly Atkins, Gensavilla Murphoy, Nancy Sutherland, my Grand daughter Nancy Arnold, my grand son William Blenferie Garey and my Great daughter Melinda Garey the two last Grand children named is to draw but one slice which would of bin their mothers part all of which parties my Executors is to pay their respective parts as quick as the said money may be collectd I nominate and appoint Bartlet Milam and William Murphoy my two Executors to this my last will and testament - In Testimony whereof I have hereunto set my hand and seal this 3 day of June 1835.
