This will acknowledge receipt of your letter of 17 January 1963, concerning your status in the National Guard with regard to ROPA and the impending reorganization.

We are certainly most desirous of retaining you, as well as our other mighty fine chaplains in our National Guard. At the present time we are in the throes of trying to come to an agreement with the National Guard Bureau on our proposed troop basis. It appears that with exception to State Headquarters, we will end up with the entire 48th Armored Division organized in Georgia under the ROAD concept. All of our non-divisional units will be absorbed into the division through reorganization and/or consolidation.

Although we haven't gotten into personnel matters too far at the present, it appears that we will be in a position to take care of all of our officers and enlisted personnel. We cannot as yet tell whether there will be any possibility of promotions immediately following reorganization, however, I ask that you not give up hope because I can assure you that we will make every effort to take care of our officers who are, as you put it, threatened by ROPA.

This will acknowledge receipt of your letter of 17 January 1963, concerning your status in the National Guard with regard to ROPA and the impending reorganization.

We are certainly most desirous of retaining you, as well as our other mighty fine chaplains in our National Guard. At the present time we are in the throes of trying to come to an agreement with the National Guard Bureau on our proposed troop basis. It appears that with exception to State Headquarters, we will end up with the entire 48th Armored Division organized in Georgia under the ROAD concept. All of our non-divisional units will be absorbed into the division through reorganization and/or consolidation.

Although we haven't gotten into personnel matters too far at the present, it appears that we will be in a position to take care of all of our officers and enlisted personnel. We cannot as yet tell whether there will be any possibility of promotions immediately following reorganization, however, I ask that you not give up hope because I can assure you that we will make every effort to take care of our officers who are, as you put it, threatened by ROPA.


