Dear Dr. Peeples,

Thank you for your interest in my genealogical research.

My maternal Grandmother was Sarah Littleberry Jones, daughter of Rebecca Ann Zeigler and Robert Fitzgerald Jones. You have my Zeigler line, so I shall give only the RFJ line: (all, Virginia.)

Robert F. Jones was a son of Littleberry Hardyman Jones (1775-1861-5) whose wife was Elizabeth Fitzgerald (1781-1847).

Littleberry H. Jones was a son of Capt. Daniel Jones IV (1744-1795) whose wife was Susannah Stith Hardyman (1755 - pr. 1783).

Daniel Jones IV was a son of Daniel Jones (1723-1772) and Mary Sturdivant.

Daniel Jones was a son of Col. Richard Jones (1692-1759) and Sarah Strahan.

Col. Richard Jones was a son of Capt. Richard Jones (1660-1741) and Amy Balte. (Richard was a son of Robert Jones & Martha Newellyn, dau. of Daniel Newellyn.)

Amy Balte was a dau. of Capt. Henry Balte and Mary Lound. Capt. Henry Balte was a son of Capt. John Balte and Martha Mallory — who was a dau. of the Rev. Thomas Mallory (Dean of Chester Cathedral) and Elizabeth Vaughan — the Rev. Thos. Mallory was a son of Sir W^m Mallory and Ursula Gale; this Sir W^m Mallory was a son of Sir W^m Mallory and June Conyers; Sir W^m Mallory (SR.) was a son of Sir John Mallory and Margaret Thuytes; this Sir John Mallory was a son Sir W^m Mallory and Joan Constable; Joan Constable was a dau. of Sir John Constable and Nora Fitzhugh; this Sir John Constable was a son of Sir John Constable and Margaret de Umfraville — dau. of Sir Thomas de Umfraville and Agnes de Grey; Sir Thomas de Umfraville was a son

of Robert de Untraville and his 2nd. wife Allaner ; this Robert was a son of Gilbert de Untraville and Elizabeth Comyn - daughter of Alexander Comyn and Elizabeth de Quincy, who was a daughter of Roger de Quincy and Helen of Galloway. Roger de Quincy was a son of Saier de Quincy and Margaret de Beaumont.

I have a Genealogy tracing Saier de Quincy to Clouis, but that gives his wife as Margaret de Bellemont. I wonder if this were the same lady ?

Elizabeth Fitzgerald (wife of Littleberry Hardyman Jones) was a dau. of Major W^m Fitzgerald and Sarah Eppes.

Major Fitzgerald was a son of Capt. W^m Fitzgerald (d. 1771) and Elizabeth Irby, dau. of Edmund Irby and Alice Blunt. (Capt. W^m Fitzgerald is "said" to have been a son of the 19th. Earl of Kildare.)

Sarah Eppes (1757- pr. 1797) was a daughter of Col. Francis Eppes⁵ and his wife Mary Williams (whose dau. Martha was the wife of Thomas Jefferson).

Col. Eppes was a son of Col. Francis Eppes⁴ and Sarah Hamlin. This Col. Eppes was a son of Col. Francis Eppes³ and Anne Isham ; Col. Francis Eppes³ (1628-1672) - husband of Elizabeth Littleberry (Worsham) - was a son of Francis Eppes who was in Virginia in 1625.

[I have a "double" Eppes line ; Col. John Hardyman (d. 18 Sept. 1711) m. Mary Eppes (Royal) - dau. of Col. Francis Eppes² and Elizabeth Littleberry.]

(Mecklenburg Co.)
My N.C. ancestors were Violet Winslow Wilson Davidson (Sylvester) dau. of { and Sarah Harper Brevard John Davidson (1779-1870) - son of Major John Davidson and Violet Winslow Wilson - (whose sister was Grandmother of President James K. Polk) -

this Violet was a dau. of Samuel Wilson and Mary Winslow¹ (dau. of Benjamin Winslow SENIOR and Mary ———). Major John Davidson was the son of Robert Davidson and Isabella Ramsey.

Sarah Harper Brevard was a dau. of Adam Brevard and his wife Mary Winslow²; Adam was a son of John Brevard and Jean McWhorter. John Brevard was a son of Jean Brevard and ~~Mary~~ ^{Katherine} McKnitt; Mary McKnitt was a child of John McKnitt, Sr. and Jane Alexander, dau. of Joseph Alexander (s. Abigail McKnitt), son of John Alexander, son of the Rev. James Alexander of Boghall (s. Mary Maxwell) dau. of John Maxwell of Southbar & Eliz. Cunningham) — the Rev. James was a son of Robt. Alexander² of Blackhouse and Boghall & Marion Hamilton (dau. of Claud Hamilton & Janet Orr) — this Robt. was a son of John Alexander³ & Eliz. Carswell — this John was a son of Robt. Alexander, Sr. and Janet Mathie; he was a son of John Alexander² — who was a son of John Alexander¹ Tenant (in 1472) of the Abbot of Paisley.

(S.C. ancestors)

Joseph Howard Sylvester (1807-1875), husband of Violet W. W. Davidson — was a son of Joseph Sylvester (1777-1812) and Martha Hampton. Joseph was a son of Asbury Sylvester (who was b. in France and d. near Statesburg, S.C. in 1808) and his first wife Jerusha Howard, dau. of Dr. Joseph Howard, M.D. and his wife Sarah Pattison (Wright). (Dr. Howard is "said" to descend from the 3rd. Duke of Norfolk, but I have seen no proof of this.)

Martha Hampton was a daughter of W^m Hampton (c. 1740? - 1805) and his 2nd. wife Naomi Vaughan (Jones) — dau. of Frances Waddell & Vincent Vaughan; Frances Waddell was a dau. of W^m Waddell of New Kent Co., Va.

W^m Hampton was a son of Richard Hampton (1688-1766) of Fauquier Co., Va. and his wife Martha; this Richard was a son of John Hampton (1650-1718) of King William County, Va. and his wife Mary Mann; this John was a son of Thomas Hampton (1623-1698) of James City Co., Va. — who was a child of W^m Hampton (1580-6 - 1652) of Middlesex, Eng. (to Va. in 1620) and his wife Joane.

My ancestor Thomas Sheppy, also, arrived in Va. in 1620 (aboard The Supply). His dau. Martha m. Edward Stratton; these were the parents of Sarah Stratton who

married Col. Richard Jones (p. 1)

Col. Francis Eppes³ helped found W^m & Mary College and
 Randolph Macon. My Fitzgeralds had a hand in founding Sidney
 Hamden. My McWhorters (Alexander^{rev.}) founded The Queen's Museum
 in Charlotte, N.C. My Davidsons founded Davidson College; my
 Drevards, Sewanee.

I am, of course, as proud of my ancestors - as you, of your's.
 And I should appreciate your help, in research, and in making contacts
 with people who can help me.
