Dear Robert:

Perhaps you can explain the following to me: Paul Bruneau & Pierre Robert are referred to as Nephews of Jas. Le Grand, Will: 1727. Up until now, I thought this meant, Pierre, Jr., & possibly confused with s-in-l.

(actually Jr.) Rev. Pierre d. 1715

In Inventory of my files, I find: Pierre Robert, Sr., & Henry Bruneau sold 400 A to Pierre Robert, Jr. (1716 Misc Prob. Bk. 56, p 258) Also, notes to the effect that Paul Bruneau was uncle to Rev. P. Robert. Could Paul B. have M sis of Daniel R.?. The Bruneaus were from d'Onis (Aunis), on W. Coast. of France, about at La Rochelle. This is just N. of Saintonge, just S. of Poitou. (Aunis included La Rochelle).

\* Pierre Robert, Jr. purchased 1000 A 1726, 15 Sept. E, part 13, p 371, 372, 373, 378 Plat. Part of these are Not indexed. That gives him 1400 A, that I can Totâ Up, from here. (If the 600 A Warrant counted = 2000 A)

Like I wrote, it sure seems that the Early Records need a real close check. Did Jean Robert sell his 150 A, prior to 1719? Maybe there are other Entries for Jean & Elmas in these Misc Records, that would help clear their affairs up. I read the Records prior to 1719 are at the Historical Commission, now Dep. of Archives & history.

Am attaching/enclosing a few more items, a couple of "guess work", which may be worth while to your Scrap Book. These, to give you a "Change of Pace", from the Smiths.

It may be, a List of the Suisse Refugees, would maybe point out some relationships, overlooked. Like the Magna Charta Barons, who were all related, I'm thinking those that came together may have been kin, more that published up to now.

The notes show: Jean & Phillippe Gendron, fils David & Cathine Gendron, Province d'Onis (Aunis). Phillip in his Will dated 1702/3, proved & Recorded 1724, has as Witness: Pierre Robert & Pierre Robert, Jr. There seems to be a strong Aunis Connection. I'll also bet Rev. P. had a Will, perhaps made while in Charleston, prior to going to Fr. Santee. It may have been lost, ruined in storage, or filed in England, but there must be some Record, of his going on.

Also noted: Pierre, Jr refers to his father, Minister Evangile (M. E. ).

Do you think the S. C. Council Journals would have an entry re the arrival of Capt. Gendron & his Party, the Ship, etc? The Guides & Indexes do NOT List, & the earliest Misc. & Bills of Sale show 1729. Somewhere, I have read, they landed at Beaufort, & walked to Charleston, a long walk I'd have to say.

Dear Robert: Your notes 1790 Census, Beaufort, S. C., remind me: James Robert, son Peter, g-s Jacques seems to have had a son, b prior to 1790 (est 1787-89), who no one has mentioned, or named.

Can it be possible he had a son James, who did not come West, but stayed in Beaufort, perhaps in Pr. William, and descendents still there till around 1840, then to Florida?

This male could be a Barlow, or Naylor, since Anna Eliz., his wife called Betsy in Tanner Records, was thought to have been a widow. He could have d y. Then he could be a cuzan, or nephew.

My reference is: 1810 Beaufort, Pr. Wm. p 119, James Robert - - - 1 - X - - - 1. 1820 Beaufort, Pr. Wm. 172/stamped 29 James Roberts, Jun 3 - - - 1 - X 2 - - 1 - & James Roberts, Sen M 1 45+ X FM 1 45+

Until this year, I had made just a brief pass at the Beaufort Robert Family, thinking the other writers, & searchers, had done a real good job on them. Now, it looks very much like their direct line was well covered, but the side lines are not fully filled in. Just in case you run into any thing on this James Robert 1810, Roberts 1820, I'd like to know about it. They were associated, tied in, with Taylor & Davis Families.

*James Roberts, born Sumter Dist, 1784, married Temperance Davis, both baptized Prince Wm Primitive Bapt. ch. 1827, moved to Fla. (Bradford Co.) 1844, died 1868, son of James Roberts who was bapt 3rd 1814, died 5 Jan. 1827.*

Stephen Robert s, son of Wm. Roberts & Eliz. Taylor, Baptized July 8, 1756, St James Parish ( Santee?), was left off the sheet on Stephen earlier. [There are, seem to be, 2 Benjamin Roberts, around 1775, b Fr. Santee, that I have not fitted in, & 2 William Roberts, again latter 1700's. Even though they have the "s", am sure they are Rev. P's.]  
So, my batting average, an't so hot!
